Item 2: No LEPC membership matters were presented.

Item 3: Review of hazardous materials incidents since the last meeting included Potential hazmat situations at Hazel & Echo

on Lakeside and another with multiple calls to the AECC of a foul smell; Fuel Spills at FM 1912 and Flying J Truck Stop; BNSF had a derail with tankers of chemicals but no chemical was released and one release in the rail yard with an injury; Carson County Pump Station owned by the City of Amarillo had a small chlorine release with a one minor injury.

Item 4: Received a report on LEPC related activities to include the updating of our website – [www.potterrandall-lepc.com](http://www.potterrandall-lepc.com), pipeline identified site registry requests, RMP's in the area and lessons learned at recent EPA audits, and information requested on hazardous materials routes.

Item 5: Received a report on the upcoming events to include Pipeline Emergency Response Safety program to be hosted by Paradigm on March 17, a Severe Weather Conference scheduled for March 19, the Homeland Security Conference in San Antonio April 26 to 29, and the Panhandle Regional Emergency Management Conference on June 9 & 10.
