



PERMISSION TO ENTER for GRAFFITI REMOVAL
(With Releases, Waivers & Other Conditions)

I/we, the above named person, being an owner or manager of the above location have requested that the City of Amarillo, Texas enter upon the above Location and remove the graffiti at/on the Location. The City of Amarillo agrees to enter and remove or cover the graffiti at its cost, upon the following terms and conditions. I am of lawful age and, acknowledge that I have read this document and understand it, and I execute it voluntarily with full knowledge of its significance.

For and in consideration of the City of Amarillo removing or covering the graffiti at no cost to me, I HEREBY CONSENT AND AGREE AS FOLLOWS:

1. Permission to Enter: I give permission for the City of Amarillo employees, volunteers, or contractors to enter (hereafter jointly and severally referred to as "City") the Location to remove or cover graffiti at and on the Location.

2. Methods: The City of Amarillo may use high pressure water, organically safe chemicals, baking soda, paint, or some combination of these methods to remove or cover the graffiti. The City will only do necessary work to cover or remove graffiti and will not otherwise improve, clean, or repair the Location.

3. Risk: While reasonable care will be used by City, there is a possibility that some minor damage could occur to my property, such as wood splinters, chipped mortar, and similar. The City is not and will not be liable to repair or pay for any such damage, or for any pre-existing defect at/on the Location. Further, I agree to warn the City about any dangers or risks that I know exist at/on the Location, that might cause harm to the City when it enters and works at/on the Location.

4. Release of Liability: I, on behalf of myself, my heirs, successors and assigns do HEREBY FOREVER RELEASE AND HOLD HARMLESS the City, its officers, employees, volunteers, contractors, assigns, and successors ("City") from any and all claims, demands, damages of every kind, law suits, loss, judgments, costs, attorney's fees, and interest that arises out of or relates any acts or omissions of City, myself, or of any other person or entity (singly or in combination) that arise out of or relate to removal of the graffiti at and on the Location.

5. General Terms: This document states the full and complete understanding between the City and myself as to the matter of graffiti removal or covering. The section labels are for convenience and do not limit or modify the substantive content. Any prior verbal or written understanding is now revoked. This agreement cannot be amended verbally by anyone.
