The City of Amarillo is seeking public comments on the 2018-2019 Public Housing Authority Action Plan. The 45 day comment period begins May 11, 2018 and ends on June 26, 2018. The Community Development Advisory Committee will conduct a public hearing on the 2018-2019 Annual Action Plan implementing the five year plan of the 2015-2019 Consolidated Plan for Housing and Community Development. The Consolidated Plan establishes priority strategies to guide the use of local and federal resources to address community development and housing needs of Amarillo's low and moderate-income neighborhoods.
