**REGULAR MEETING**

1. **Minutes:**

2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the location stated:**  
This resolution sets the date and time for a public hearing on December 7, 2017, at 4:00 p.m. to determine if the property at 2404 S Washington Street constitute public nuisance and thereby declare as a dangerous structure and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the location stated:**  
This resolution sets the date and time for a public hearing on December 21, 2017, at 4:00 p.m. to determine if the properties at 1429 NW 11<sup>th</sup> Avenue, 1409 N Fairfield Street and 2104 Tank Lane constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
