Mr. Robinson established a quorum, called the meeting to order at 10:03 a.m., and the following items of business were conducted:

<u>ITEM 1.</u> Consider Minutes. Mr. Robinson presented the minutes from the last regular meeting held September 20, 2017. Mr. Mason made a motion to approve the minutes as presented. Mr. Drerup seconded the motion and it carried unanimously.

<u>ITEM 2.</u> Consider Investment Resolution. Ms. Storrs presented the Fund's Investment Resolution at September 30, 2017. A motion was made by Ms. Bonner, seconded by Mr. Drerup and unanimously carried to approve the investment resolution as presented.

<u>ITEM 3.</u> Presentation of Revenue and Expenditures Summary. Ms. Storrs presented the Fund's Summary of Revenue and Expenditures at September 30, 2017 and reviewed a total market value of \$164,849,916.12. She reviewed total receipts of \$873,902.92 versus total disbursements of \$1,036,178.14. Ms. Storrs explained that the Fund's investments were within Policy limits with 1.10% invested in cash, 25.50% in bonds and 73.40% in stock. She noted that all employee/employer contributions were made on time and at the correct percentages for the month of September.

<u>ITEM 4.</u> Canvassing of Election Results. Mr. Robinson reported that they held a total of 9 meetings, with 3 meetings held each day on 10/13/17, 10/16/17 and 10/17/17. A total of 261 members were eligible to vote, only 213 members actually voted. On Ballot Item 1: 183 members voted in favor, 28 voted against, 2 did not vote on the issue. On Ballot Item 2: 162 members voted in favor, 50 voted against, 1 did not vote on the issue. A motion was made by Mr. Frigo, seconded by Ms. Bonner and unanimously carried to approve the canvassing of the Election.

<u>ITEM 9.</u> Consider Form 100, Update of Beneficiary, for Clay Gibson. A motion was made by Mr. Mason, seconded by Mr. Drerup and carried unanimously to approve Clay Gibson's Form 100, Update of Beneficiary.

<u>ITEM 10.</u> Discussion of State of the Texas Local Fire Fighter's Act (TLFFRA) Pension Conference 2019. Amarillo will host the 2019 TLFFRA pension Conference for the first time since 1991.

<u>ITEM 11.</u> Review and Consider Disability Pension for Mikal Orr. The Board convened into Executive Session, under Sections 551.0785 of the Texas Open Act, at 10:18 a.m. At 10:28 a.m., the Board completed its Executive Session. A motion was made by Mr. Mason to approve the disability pension benefits for Mr. Orr and a partial pension payment until final benefit amounts are available for Board approval. The motion was seconded by Mr. Drerup and unanimously carried.

<u>ITEM 12.</u> Public Forum. Marc Lusk commented on Item 2 and thanked the Board for their dedication to present and future Firefighters.

There, being no further business, Mr. Frigo made a motion to adjourn the meeting. Mr. Drerup seconded the motion and the meeting adjourned at 10:28 a.m. This meeting was recorded and all comments are on file with the City Finance Department.
