2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on January 4, 2018, at 4:00 p.m. to determine if the properties at 1340 NW 9<sup>th</sup> Avenue, 3806 NE 12<sup>th</sup> Avenue and 1402 N Johnson Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
