2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on February 1, 2018, at 4:00 p.m. to determine if the properties at 1634 NW 14th Avenue, 1635 NW 15th Avenue and 3404 N Bolton Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1402 N Johnson Street.
