This resolution sets the date and time for a public hearing on March 1, 2018, at 4:00 p.m. to determine if the properties at 4120 S Ong Street, 4600 Pioneer Lane and 623 S Vernon Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
