This resolution sets the date and time for a public hearing on April 5, 2018, at 4:00 p.m. to determine if the properties at 4619 Eagle Lane and 4818 Mountain Drive constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
