2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on May 3, 2018, at 4:00 p.m. to determine if the properties at 911 N Tennessee Street, 2406 Wichita Avenue and 1112 SE 12<sup>th</sup> Avenue constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
  
3. **Resolution – Public Hearing**  
This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 4619 Eagle Lane.
  
4. **Public Forum:**  
Interested citizens may comment on matters pertaining to policies, programs or action of the Condemnation Appeals Commission.
