#### **Proposed Site Activities**

#### Well Install - Site Sampling - Waste Disposal

This document contains the Scope of Work for the installation of five (5) additional monitoring wells, as well as the associated Cost Schedule. Also attached are the Cost Schedules for one (1) year of Quarterly Monitoring, and two (2) quarters of Hand Bailing.

In accordance with Texas Commission on Environmental Quality (TCEQ) request for additional plume delineation of the subject property, Talon/LPE (Talon) proposes installing five (5) groundwater monitoring wells.

Following completion of a new line locate, Talon will mobilize to the site to being installation of the required monitoring well. Based on previous drilling activity, Talon will utilize a truck mounted hollow stem air rig to drill to the base of the uppermost groundwater-bearing unit (anticipated to be approximately 145 feet below grade).

Soil samples will be collected at (5) five foot depth intervals throughout the drilling process. A split of each sample interval will be screened for VOCs in the field using a properly calibrated PID by EPA Method 21, in the headspace of each soil sample.

An environmental scientist or geologist will supervise the drilling, logging, and sample collection and analysis preparation. Three soil samples from each borehole will be submitted to the laboratory for analysis of petroleum hydrocarbons. Samples collected from the highest PID reading, the groundwater interface, and the bottom of the well bore will be properly containerized and submitted to a NELAC accredited laboratory. Each submitted soil sample will be analyzed for BTEX via EPA method SW-846/9021B and for TPH via TCEQ method TX1005. The soil sample with the highest TPH concentration will also be analyzed for PAH.

Once the base of the uppermost groundwater bearing unit is reached, the monitoring well will be installed using 4-inch diameter Schedule 40 PVC with screen of appropriate length, as determined by the onsite geologist, with solid PVC casing above the screen extending to the surface. Monitor well will be screened from 115-145 feet below grade unless visible saturation is noted above this depth. The annular space around the screened interval and two feet above it will be filled with an appropriate sieve-size sand pack to the surface. Each well will be completed with a flush mounted concrete sealed surface completion to prevent any impedance of vehicle traffic.

The well will be properly developed and will be sampled following development to include the additional monitoring wells onsite. Analysis of the groundwater samples collected will include TPH by TCEQ method TX1005 and Benzene, Toluene, Ethylbenzene, and Xylenes (BTEX)/MTBE by SW-846 method 8260B. PAH will be run on the sample with the highest TPH concentration.



Once the wells are installed and the proper surface completion is in place, Talon/LPE will survey the well casing top to a common benchmark. This data will be used to create an updated groundwater gradient map that will aid in future site assessment activities. An updated site map, gradient map, benzene plume map, and soil/groundwater concentration map will be submitted in the Risk Based Assessment Report.

Removed soils and purge water will be placed in 55-gallon steel drums and kept on-site. Once the analytical results are received from the laboratory, the wastes will be profiled and shipped for disposal to an authorized disposal facility.

Upon completion of the monitoring well installation, monitoring well sampling, and receipt of the laboratory analytical data, Talon will prepare an updated Assessment Report Form addendum and submit to the TCEQ.

#### **Cost Estimate**

Talon provides the costs to complete this work plan as an estimate of potential costs only. Actual costs will be billed at standard Talon/LPE 2017 conventional rates on a time and materials basis.

Talon/LPEs costs reflect the proposed work by task and include anticipated outside professional and other direct costs associated with the completion of the scope of work described herein. The estimated cost to install five (5) groundwater monitoring wells, sampling, and waste disposal is **\$54.956.20**.



### **Agenda Caption**

Aviation Clear Zone Easement, being 4,800 feet above mean sea level above the plat of Holiday South Unit No. 10 a suburban subdivision to the City of Amarillo, being an unplatted tract of land in Section 177, Block 2, AB&M Survey, Randall County, Texas.

### **Agenda Item Summary**

The above referenced Aviation Clear Zone (ACZ) Easement is being requested by the City of Amarillo and is associated with the plat Holiday South Unit No. 10.

To ensure safety of operation and protection of air traffic operating into and out of the airport, future physical development around the airport needs to be regulated. In 1981, the Texas Legislature enacted the Airport Zoning Act, cited as Chapter 241 of the Local Government Code, which authorized cities in the state to establish and administer regulations pertaining to the height of structures and compatible land uses in the vicinity of the airport. One of the tools established in the Amarillo Code of Ordinances that allows the City of Amarillo to regulate this type of development is the Airport Height Hazard and Zoning Regulations (Chapter 4-9) which establishes minimum requirements to control the height and use of structures that may develop in the vicinity of the airport.

The ACZ Easement document is established during the platting of a tract of land to set the height regulations for noting on the associated plat, and the legal document is signed by the owner/developer of the tract. The placement of the note on the plat ensures that the height regulation is easily found by any future owner of the tract of land. Each ACZ Easement has an associated height regulation that is determined by the tract's proximity and location around the airport. For example, areas at the end of the runway will likely have a lower height regulation that ones at the same distance that are located adjacent to the length of the runway. The reason for this is because aircraft taking off or landing will need to be at a lower altitude during its approach or departure portion of the traffic pattern for the each associated runway.

This ACZ Easement is establishing a height regulation of 4,800 feet above mean sea level for the plat of Holiday South Unit No. 1.

### **Requested Action**

Planning and Legal Staff have reviewed the associated Aviation Clear Zone Easement and the item is ready for City Council Consideration as a consent agenda item.





Staff also considers how any zoning change would impact the Comprehensive Plan's recommended Neighborhood Unit Concept (NUC) of development whereby non-residential land uses are encouraged at section-line arterial intersections with a transition to residential uses as development occurs away and inward from the arterial intersections. Staff also considers the principles and recommendations laid out within the Comprehensive Plan, as well existing zoning and development patterns in the area.

The Neighborhood Unit Concept is also a key piece of the adopted plan, in which zoning transitions from areas of higher density at section line corners to areas of lower density toward the center of the section. This concept of development ensures that commercial areas will have less of an impact to residential areas. This particular square mile section is a majority of either a playa lake (large floodplain) or unannexed land. However, this request does follow the NUC since it is near the northeast corner of Section L-16, along the arterial street (SW 58<sup>th</sup> Avenue). The western portion of this property is already zoned Light Commercial (LC), thus the opportunity arose to create a transition between it and the lower density zoning district Agricultural (A). After looking at existing uses and the proposed use General Retail District (GR) was recommended to the applicant. Therefore, staff believes this property is in compliance with the NUC development pattern since it will create a transition zone between higher intensity uses and lower intensity uses.

The adopted Comprehensive Plan contains a number of action strategies that are to be followed when making decisions about land use, development, and other community elements. These include:

- Encourage infill development to achieve more efficient utilitization of the City's existing resources and infrastructure. (page 3.3, Growth Management & Capacity).
- Promote infill development of various types as appropriate areas to reduce urban sprawl and duplication of public services thereby saving tax dollars. (page 3.3, Growth Management & Capacity).



This tract of land was initially zoned Agricultural District (A) when parts of it were annexed in 1960, 1977, and 1997, respectively. In 2002, it was changed to Agricultural with a Specific Use Permit (#99) in 2002 for the YMCA outdoor ballpark, soccer fields, and an indoor gymnasium with associated uses. The property has never fully developed into what was proposed and approved in 2002 per the approved specific use permit site plan.

The requested zoning change would create a transition for the NUC pattern between the Light Commercial District (LC) zoning in the east and that the remainder of the Netplex site, which is zoned Agricultural District with an SUP #99 (A/S-99). This proposed restaurant use that will service alcohol, along with the existing uses on this portion of the property, would be allowed within this zoning district by right, eliminating the need for the SUP.



PD-130 has had multiple amendments approved since its creation, and as a result of these, the files and associated ordinances were quite complicated and difficult to follow, creating an administrative issue when determining what regulations applied to each part of the site, essentially necessitating a review of each file and ordinance for every circumstance. As such, the Planning department took this opportunity to clean up these previous approvals and compose one single, organized, and easily reviewable ordinance which addresses all previous approvals and this proposed amendment. This was approved 3/13/2017 by the P&Z commission and approved by City Council on final reading 6/13/2017.

The items associated with this Planned Development hearing are:

• The establishment of PD-130 regulations and the associated site plan for the proposed new development of Lots 10-12, Block 223.

Per Section 4-10-104 of the Zoning Ordinance, a site plan shall be approved and filed as part of the Planned Development ordinance, meaning the approval of the PD ordinance shall constitute approval of the associated site plan as well.

As mentioned before, the proposed new development of Lots 10-12, Block 223 is as an office with an accessory use of a bus garage. The building will be two stories tall, and will be faced with brick veneer with aluminum storefront type windows. One parking lot will be built on the south side of the building, with a wooden and brick fencing established around them to separate and screen them from the residences to the south. 



This rezoning request is consistent with the current pattern of development within the area, which is predominately office or medical uses. The existing PD and requested O-2 zoning district are consistent with the conditions of the area.

This rezoning request is consistent with the adopted 2010 Comprehensive Future Land Use and Character (FLUC) Map, which designates this area for a future "business park" land use. The Comprehensive Plan states that the development type in this designation should be that associated primarily with office, medical, and technology/research uses, intended to create a highly attractive business investment environment. Characteristics of this development should be that of a suburban, campus style featuring enhanced site and building design. The existing building on the site is in character with this "business park" designation and the surrounding building style. One of these strategies is an emphasis on character emphasis of developments (page 2.24, Land Use & Community Character). 


