The invocation was given by Kevin Deckard, Polk Street United Methodist Church. A proclamation was presented for "National Community Planning Month." Mayor Nelson led the audience in the Pledge of Allegiance.

Mayor Nelson established a quorum, called the meeting to order, welcomed those in attendance and the following items of business were conducted:

PUBLIC COMMENT:

Dwight Folkner, 4308 Parker Street, spoke on Item 4, the need for a four-way stop sign at 43rd Avenue and Parker Street. James Schenck, 6216 Gainsborough Street, spoke on the boards and commissions letter printed in the newspaper. Mr. McKamie stated that the publication was a public relations letter. Mr. Schenck spoke on the specifics of the MPEV agreement. Mr. Schenck also inquired if the Mayor would recuse herself from voting on the TIRZ items. The Board voted 4-0 to recommend to the City Council that a four-way stop be placed at Parker Street and Southwest 43rd Avenue. ITEM 8: Mayor Nelson presented an item approving a Tax Increment Reinvestment Zone #1 (TIRZ #1) Developer Agreement for the reimbursement of 90% of the annual ad valorem tax increment from the participating taxing jurisdictions generated annually for ten years, with a maximum reimbursement of \$300,000, as well as the reimbursement of \$50,000 of public improvements associated with this project, for the redevelopment of the Levine's building into a mixed-use commercial property at 800 South Polk. This item was presented by Andrew Freeman, Economic Development Manager, and AJ Fawver, Planning Director. Randy Gideon, 222 W. Exchange Avenue, #8, Fort Worth, Texas, stated the expenses were based on the streetscape, utilities, the historic façades needs, and providing for additional infrastructure. Mayor Nelson read the names of the board members on the TIRZ #1 board. Scott Bentley, Chairman of TIRZ #1; explained how these projects came about and the board's recommendations. Motion was made by Councilmember Powell, seconded by Councilmember Sauer, that this item be approved.

Voting AYE were Mayor Nelson, Councilmembers Hays, Powell, Sauer and Smith; voting NO were none; the motion carried by a 5:0 vote of the Council.

ITEM 9: Mayor Nelson presented an item approving a Tax Increment Reinvestment Zone #1 Developer Agreement for the reimbursement of 90% of the annual ad valorem tax increment from the participating taxing jurisdictions generated annually for ten years, with a maximum reimbursement of \$200,000 for the redevelopment of the Woolworth building into a mixed-use commercial property at 626 South Polk. This item was presented by Andrew Freeman, Economic Development Manager, and AJ Fawver, Planning Director. Motion was made by Councilmember Powell, seconded by Councilmember Smith, that this item be approved.

Voting AYE were Mayor Nelson, Councilmembers Hays, Powell, Sauer and Smith; voting NO were none; the motion carried by a 5:0 vote of the Council.

ORDINANCE NO. 7681

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS: AMENDING THE MUNICIPAL CODE OF THE CITY OF AMARILLO, CHAPTER 16-3, ARTICLE XXI, SECTION 16-3-1004 to AMEND SCHEDULE OF DUAL RIGHT TURN LANES; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEALER; PROVIDING FOR PUBLICATION AND EFFECTIVE DATE.

WHEREAS, the Amarillo Traffic Commission recommends allowing dual right turns at the location described below; and,

WHEREAS, the City Council has considered the recommendation of the Traffic Commission and the information provided during the two readings of this ordinance, and now concludes that the recommendation balances traffic flow with public health and safety;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS:

SECTION 1. That Chapter 16-3, Article XXI, Section 16-3-1004 be and hereby is amended to read as follows:

Sec. 16-3-1004. Schedule D, dual turns.

S. Buchanan St.

S. Fillmore St.

SECTION 2. Severability. If any provision, section, subsection, sentence, clause or the application of same to any person or set of circumstances for any reason is held to be unconstitutional, void or invalid or for any reason unenforceable, the validity of the remaining portions of this ordinance or the application thereby shall remain in effect, it being the intent of the City Council of the City of Amarillo, Texas in adopting this ordinance, that no portion thereof or provision contained herein shall become inoperative or fail by any reasons of unconstitutionality of any other portion or provision.

SECTION 3. Repealer. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed to the extent of conflict with this ordinance.

SECTION 4. Publishing and Effective Date. This ordinance shall be published and become effective according to law.

SUBJECT: Dual Right Turn: SE7th Avenue

In July, the two blocks of SE7th Avenue between Fillmore and Buchanan was converted from one-way to two-way traffic movement. With the conversion, the westbound dual right turn on 7th was shifted from Buchanan to Fillmore. This shift has made it necessary to update the Municipal Code to reflect this change.

The Traffic Engineering Department recommends that the Traffic Advisory Board forward to the City Council a recommendation to modify Section 16-3-1004 Schedule D, Dual Turns of the Amarillo Municipal Code as shown below:







APPROVAL OF LEASE BETWEEN THE CITY OF AMARILLO AND GTM MANUFACTURING, LLC FOR USE OF THE FORMER BEN E. KEITH DISTRIBUTION CENTER PROPERTY:

This item is for a two year property lease between the City and GTM Manufacturing, LLC (GTM) for a portion of the former Ben E. Keith Distribution Center property at Interstate 40 and South Spruce Street.

Agenda Item Summary

The City acquired this property in 2007 for the future expansion of the adjoining existing City of Amarillo Service Center. At that time, the City did not need to move in to this building and decided to lease it to Amarillo Economic Development Corporation (AEDC) for short-term use related to economic development and new business job creation. The building is approximately 81,916 square feet.

After entering into the lease with AEDC in April 2007, AEDC leased the property to GTM in May 2007 for a 123 month term. This lease expired in August 2017 and GTM has since been on a month to month lease. Since the City has plans to convert the building to city operations in the near future, it was recommended the City should lease directly to GTM for any remaining time period needed. The new terms are as follows:

Monthly Rent: \$11,263

Term: 2 years, with no renewals

Termination: Either party may terminate the agreement without cause with 60 days written notice

LEASE AGREEMENT

THIS LEASE AGREEMENT ("LEASE") is made and entered into by and between the CITY OF AMARILLO, TEXAS ("LESSOR"), a Home Rule Municipal Corporation situated in Potter and Randall Counties, State of Texas, and the GTM MANUFACTURING, LLC, a Texas Limited Liability Company, having its principal place of business in Amarillo, Potter County, Texas ("LESSEE"), upon the following terms, performable in Potter County, Texas.

WITNESSETH:

WHEREAS, LESSOR owns, controls, and operates approximately 6.969 acres of ground (hereinafter referred to as "LAND"), including warehouse buildings containing 81,916 net rentable square feet (hereinafter referred to as "BUILDING"), specifically described in Exhibit "A," attached hereto and incorporated herein, located thereon in the City of Amarillo, Potter County, State of Texas, (hereinafter the LAND and BUILDING are collectively referred to as "PREMISES");

WHEREAS, LESSEE desires to lease a portion of the PREMISES for the purpose of warehouse use for their business operations within the City of Amarillo, Texas for a two (2) year term and establish a rental amount for said LEASE.

NOW, THEREFORE, for and in consideration of the mutual promises, covenants, terms, and conditions, both general and special, as hereinafter set forth, LESSOR hereby grants to LESSEE the rights and privileges hereinafter described, and LESSEE agrees to accept those duties, responsibilities, and obligations as hereinafter set forth. The parties hereto agree as follows:

1. **PREMISES**. LESSOR hereby leases and demises to LESSEE, and LESSEE hereby takes and leases from LESSOR an area formerly known as the Ben E. Keith Warehouse, which is entirely enclosed by a chain link fence and is comprised of approximately 6.969 acres of ground ("LAND"), including warehouse buildings with 81,916 net rentable square feet ("BUILDING"), being more particularly described in Exhibit "A" attached hereto and made a part hereof for all purposes ("PREMISES").

- 2. **TERM**. The term of this LEASE shall be for two (2) years and shall begin on the latter of the signature dates below and terminate two (2) years from such signature date on this document.
- 3. **RENT**. LESSEE covenants and agrees to pay to the LESSOR as Base Rent for said PREMISES, the monthly sum of Eleven Thousand Two Hundred and Sixty-Three and NO/100 Dollars (\$11,263.00.) payable on the first Friday of each month.
- 4. LATE PAYMENT CHARGE. Other remedies for nonpayment notwithstanding, if the monthly rent payment is not received by LESSOR on or before the 10th day after the due date, then LESSEE agrees to pay LESSOR a late payment charge of one percent (1%) of the past due amount, said late payment charge to be paid immediately upon receipt by LESSEE of written notice from LESSOR of late payment. If the LESSEE has more than two late payments, the late payment charge will increase to five percent (5%) of the past due amount for all subsequent late payments.
- 5. **FAILURE TO PAY RENT**. Upon LESSEE'S failure to pay the rent in advance or any late payment charge, as set forth herein above, or to keep any of the covenants of this lease, after having received at least thirty (30) days written notice of such deficiencies from LESSOR, LESSOR may declare this lease forfeited, at its discretion, and its agent or attorney will have the right to enter, hold, occupy, and repossess the entire PREMISES described above without liability.
- 6. **TERMINATION.** LESSOR or LESSEE may terminate this LEASE without cause at any time by giving the other party sixty (60) days prior written notice thereof.
- 7. **TAXES**. LESSEE agrees to be responsible for and pay any property tax, special assessments, and other taxes levied by the County, State, or any other taxing body during the continuance of this LEASE, and extension thereof.

8. INDEMNITY INSURANCE.

A. LESSEE AGREES TO INDEMNIFY AND HOLD LESSOR HARMLESS FROM AND AGAINST ALL LIABILITY FOR INJURIES OR DEATH TO PERSONS OR DAMAGE TO PROPERTY CAUSED BY ANY CONDITION OF PREMISES OR BY LESSEE'S USE OR OCCUPANCY OF PREMISES, OR THAT OF ITS SUBLESSEES, AGENTS OR EMPLOYEES; INCLUDING INJURY, DAMAGE OR LOSS OCCASIONED BY ANY PREEXISTING CONDITION OF PREMISES SAID PREMISES BEING ACCEPTED BY LESSEE IN ITS PRESENT "AS-IS" CONDITION; AND PROVIDED FURTHER, THAT LESSEE SHALL GIVE TO LESSOR PROMPT AND TIMELY NOTICE OF ANY CLAIM MADE OR SUIT INSTITUTED WHICH, IN ANY WAY, DIRECTLY OR INDIRECTLY,

CONTINGENTLY OR OTHERWISE, AFFECTS OR MIGHT AFFECT LESSOR, AND LESSOR SHALL HAVE THE RIGHT TO COMPROMISE AND DEFEND THE SAME TO THE EXTENT OF ITS OWN INTERESTS.

B. LESSEE shall, at its own expense, at all times keep in force insurance of the following types, and in not less than the following amounts, issued by a company or companies with a Best Rating of B+ or better and insuring against all liability for accidents arising out of or in connection with LESSEE'S use and occupancy of the PREMISES. At the time this Lease is executed, LESSEE shall furnish to LESSOR certificates evidencing such insurance, and LESSOR shall further be furnished with a certificate to the effect that such insurance shall not be canceled or materially changed without thirty (30) days actual prior notice to LESSOR. The types and minimum limits of such insurance shall be as follows:

Fire and Extended Coverage

Insure value of LESSEE'S personalty, including improvements and betterments. Fire and Extended Coverage on LESSEE'S insured property shall contain a waiver of subrogation in favor of LESSOR.

Insurance coverage must include LESSOR as an Additional Insured for General Liability and a waiver of subrogation in favor of LESSOR in the Workers' Compensation policy. Failure to maintain the required insurance coverage shall be cause for immediate suspension of LESSEE'S use of the PREMISES and cancellation of this LEASE.

C. LESSOR shall, at its own expense, at all times during the term of this LEASE or any extension hereof, keep in force a fire and extended coverage policy insuring the PREMISES against physical loss or destruction due to any and all risks including, but not limited to fire, wind storm, or other casualty in an amount sufficient to cover the full replacement value of the PREMISES. Upon being invoiced therefor,

LESSEE shall pay for that portion of LESSOR'S Fire and Extended Coverage insurance that applies to the PREMISES.

- 9. **DAMAGE OR DESTRUCTION OF BUILDINGS**. If the BUILDINGS or any portion thereof, shall be partially damaged by fire, the elements, or other casualty, but not rendered unusable, the same shall be repaired by LESSOR and rent shall continue to be paid as agreed upon by this LEASE. If the damage shall be so extensive as to render all of the BUILDINGS unusable, LESSOR shall have the option of terminating this LEASE or repairing the BUILDINGS. In the event LESSOR has elected to repair the BUILDINGS, then there shall be a proportionate abatement of rentals due hereunder for the period beginning on the date the BUILDINGS were rendered unusable until such time as BUILDINGS are rendered usable.
- 10. MAINTENANCE OF BUILDINGS AND PREMISES. LESSEE by execution of this LEASE acknowledges that the PREMISES are in good condition and repair. Upon commencement of this LEASE, LESSEE shall maintain PREMISES, as well as the fixtures connected therewith, in a reasonable state of repair and appearance at all times. Upon termination of this LEASE, LESSEE will deliver up the PREMISES to LESSOR in good order, condition, and repair, reasonable wear and tear alone being excepted. This section does not apply to the condition of the roof.
- 11. **UTILITIES**. LESSEE will pay all utility charges for PREMISES. LESSEE further agrees not to install any additional equipment on the PREMISES or change the frequency, power, or type of its existing equipment on the PREMISES without first submitting to LESSOR a written proposal regarding the proposed configuration and obtaining the City's written consent.

12. ALTERATIONS.

- a. During the term hereof, LESSEE shall have the right, at LESSEE'S sole expense, to erect upon PREMISES such buildings, fixtures, structures, additions and improvements as may be required in connection with LESSEE'S operations hereunder, and to install therein and thereon such equipment and facilities as LESSEE may deem necessary and desirable; provided, however, that no such building, fixture, structure, addition or improvement shall be made or installed by LESSEE without the prior written consent of LESSOR. LESSEE covenants and agrees, prior to the installation or making of any such building, fixture, structure, addition or improvement, to submit a general plan, location, design and character thereof to LESSOR for approval, which approval, LESSOR agrees shall not be unreasonably withheld or delayed. LESSEE will obtain any required building permits for alterations and improvements made to PREMISES.
 - b. Except with regards to buildings and additions erected on

PREMISES by LESSEE, all fixtures, improvements, structures, and other property brought, installed, erected, or placed by LESSEE in, on, or about the PREMISES shall be deemed to be personal property and remain the property of LESSEE, and LESSEE shall have the right at any time during the term of this LEASE or any extension thereof and for an additional period of sixty (60) days after the expiration or other termination of this LEASE to remove any or all of its property from the PREMISES, provided LESSEE is not in default in its payments to LESSOR hereunder and subject further to LESSEE'S obligation to repair all damage, if any, resulting from such removal. Any and all property not removed by LESSEE prior to the expiration of the aforesaid sixty (60) day period shall thereupon become a part of PREMISES, and title thereto shall thereupon vest in LESSOR free of any liens or encumbrances, except that such sixty (60) day period may be extended by LESSOR at its discretion.

c. LESSEE shall not permit any mechanic's, material men, or general contractor's lien or liens to be placed on PREMISES or alterations and improvements thereon during the term of this LEASE or any extension thereof. In the event of filing of any such lien, LESSEE will promptly pay same. If LESSEE defaults in payment for more than twenty (20) days after its receipt of notice of the lien, LESSOR shall have the option to pay same and LESSEE shall repay that amount, plus any reasonable expenses and interest, to LESSOR immediately upon rendition of a bill therefore from LESSOR. Notwithstanding the above, LESSEE shall have the right to protest or contest, in good faith, the amount or validity of the lien, and LESSOR shall not take any action with respect to the lien while same is being protested or contested.

B USE OF PREMISES. LESSEE covenants to use PREMISES for warehouse purposes and for such other purposes as are lawful. LESSEE agrees that in its use of PREMISES, LESSEE will comply with all applicable laws, ordinances, and regulations of the United States Government, the State of Texas, LESSOR, and any other governmental agency having jurisdiction and control over PREMISES and relating to LESSEE'S occupancy and use of PREMISES.

14 NO ASSIGNMENT OR SUBLEASE. This LEASE is not assignable. LESSEE shall not sublease the PREMISES.

15 SIGNS. LESSEE shall not attach, affix, or permit to be attached or affixed any signs or placards upon the outside of the PREMISES, without the consent in writing of the LESSOR.

16 ACCESS. Subject to reasonable notice, LESSOR, its officers, agents, or

employees shall, during LESSEE'S normal business hours and accompanied by LESSEE, have access to PREMISES for the purposes of examining the same to ascertain if they are in compliance with the requirements of this LEASE. LESSEE hereby agrees to provide LESSOR, its officers, agents, or employees easy, convenient, and unobstructed access to PREMISES.

17 HAZARDOUS MATERIALS. If LESSEE uses, stores, or generates any hazardous materials or wastes on PREMISES, LESSEE will obey all Federal, State, and Local laws governing such materials. In the event that hazardous materials are discharged on PREMISES, LESSEE will be responsible for all costs, fines, and activities related to the contamination and will provide LESSOR with proper documentation evidencing that a complete clean-up has occurred. LESSEE AGREES TO ACCEPT ALL LIABILITIES RELATED TO THE USE, STORAGE, DISPOSAL, AND CLEAN-UP OF ALL HAZARDOUS MATERIALS ON THE PREMISES AND TO INDEMNIFY AND HOLD LESSOR HARMLESS FOR SAME, except for such result or have resulted from the operation of LESSOR'S fuel tanks described in Paragraph 1 above.

18 WASTE AND CLEANING. LESSEE shall keep PREMISES clean and shall dispose of all debris and waste matter which may accumulate. LESSEE will provide suitable covered metal receptacles for all garbage, trash, and other refuse. Piling of boxes, cartons, barrels or other similar items in an unsightly or unsafe manner on or about the PREMISES is prohibited. LESSEE will provide for the adequate and sanitary handling and disposal of all trash, garbage, and other refuse caused as a result of business operations.

A NONDISCRIMINATION. LESSEE assures that it will undertake an affirmative action program as required by 14 CFR Part 152, Subpart E, to insure that no person on the grounds of race, creed, color, national origin, condition of disability, or sex be excluded from participating in any employment activities covered in 14 CFR Part 152, Subpart E. LESSEE assures that no person shall be excluded on these grounds from participating in or receiving the services or benefits of any program or activity covered by this subpart. LESSEE assures that it will require that its covered sub-organizations provide assurances to LESSEE that they similarly will undertake affirmative action programs, and they will require assurances from their sub- organizations as required by 14 CFR Part 152, Subpart E, to the same effect.

20 NOTICES. All notices or demands provided for which may be given by either party to the other under the terms of this LEASE shall be in writing, signed by the party giving the notice or making the demand, and deemed validly served or delivered upon physical delivery or upon deposit in the United States mail, registered, returned

receipt requested, postage and registration fees prepaid, addressed as follows:

21 AMENDMENTS, ENTIRE UNDERTAKING. This LEASE shall not be altered, changed, amended, or extended except by instrument in writing signed by the parties hereto. This LEASE contains the entire undertaking and understanding of the parties hereto, and LESSOR and LESSEE accepting the same, acknowledge that there is no other written or oral understanding or promises between the parties in respect to the demised PREMISES, and no representations, except those that may be contained herein, have been made to induce LESSOR or LESSEE to enter into this LEASE.

- 22 SEVERABILITY. If any provision of this LEASE is declared invalid or unenforceable, such provision shall be deemed modified to the extent necessary to render it valid and enforceable as long as said modification is reasonable within the intent the parties as originally expressed. In the event such provision may not be so modified, the unenforceability or invalidity of any provision shall not affect any other provision of this LEASE, and this LEASE shall continue in force and effect as if such provision had not been included in this LEASE.
- 23 GOVERNING LAW AND VENUE. This LEASE shall be governed by the laws of the State of Texas. All litigation arising out of this Agreement shall be brought in courts sitting in Texas with a venue in Potter County, Texas.

This is the first reading of an ordinance establishing guidelines, criteria, and procedures related to the renaming of City streets.

Agenda Item Summary

Staff recommends approval as presented

In the past, the City has handled naming/renaming of streets through an informal process with no set criteria or public hearing process. City Council directed staff to draft a new ordinance with specific guidelines and procedures to process any requests received. Of the criteria, the major components include a petition requirement showing 51% of the abutting property owners in favor of the change, as well as a 2 year waiting period after someone has passed away before they are eligible to apply.

The ordinance also establishes a public hearing process which goes through Planning & Zoning and City Council before the item is considered, as well as staff review and recommendation based on the ordinance requirements.

A public meeting was held on Monday, October 23rd where feedback was gathered. Overall, the citizens in attendance were very supportive of having a new ordinance in place to guide future requests.

WHEREAS, the City Council has considered the norms of the community to arrive at an appropriate procedure and reasonable process for the naming of City streets, and now wishes to codify the same to effectuate this policy; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS:

SECTION 1. The Amarillo Municipal Code, Chapter 4-6, Article III, be and hereby is amended to read as follows:

DIVISION 3. - STREET ADDRESSES AND NAMES

Sec. 4-6-144. - Definitions.

In this division:

DIRECTIONAL PREFIX means an indicator of the direction a roadway passes
For example, in the street name "North Franklin Road," North is the directional prefix.
DIRECTIONAL SUFFIX means an indicator of address location. For example in the address "137 Franklin Road W," W is the directional suffix.
in the address 137 Plankim Road W, W is the directional surffx.
FUNCTIONAL CLASSIFICATION means the systematic classification of
roadways in categories according to their access and movement attributes. Minor streets
residential and community collectors, minor and principal arterials, and freeways and
expressways are functional classifications of roadways. Minor streets usually provide
access to individual lots. Collector streets provide access between the minor streets and
arterials. Arterials link areas of the city and carry traffic to freeways and expressways
which primarily provide movement to locations throughout the region.

COMMEMORATIVE STREET NAME SIGNS are additions to the street name
and will not change the street address. Existing street name shall be retained and a
supplemental sign or plaques shall be installed. Commemorative street name signs shall

ORDINANCE NO. 7684:

This is the first reading of an ordinance establishing guidelines, criteria, and procedures related to the renaming of City land and facilities.

Agenda Item Summary

In the past, the City has handled naming/renaming of land and facilities through an informal process with no set criteria or public hearing process. City Council directed staff to draft a new ordinance with specific guidelines and procedures to process any future requests received.

The ordinance establishes a public hearing process which goes through the appropriate board or commission depending on the type of renaming being requested (i.e. Parks, Airport, etc.) and City Council before the item is considered, as well as staff review and recommendation based on the ordinance requirements.

There are included criteria for living, deceased, and city officials/staff to provide guidance to staff, boards, and city council when reviewing the applications.

A public meeting was held on Monday, October 23rd where feedback was gathered. Overall, the citizens in attendance were very supportive of having a new ordinance in place to guide future requests.

ORDINANCE NO.	

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS ESTABLISHING A POLICY AND PROCESS FOR THE NAMES OF CITY OWNED LAND AND FACILITIES; INCLUDING A SEVERABILITY PROVISION; INCLUDING A REPEALER; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City Council finds that it is in the best interests of the citizens of the City of Amarillo that a policy and process be established for the naming of City-owned land and facilities; and

WHEREAS, the City Council has considered the norms of the community to arrive at an appropriate procedure and reasonable process for the naming of City-owned land and facilities, and now wishes to codify the same to effectuate this policy; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AMARILLO, TEXAS:

SECTION 1. The Amarillo Municipal Code, Chapter 4-6, Article III, be and hereby is amended to add Division 4 and to read as follows:

DIVISION 4. – NAMES OF CITY-OWNED PROPERTY AND FACILITIES

Sec. 4-6-153. - Definitions.

Land and Facilities includes parks, airport facilities, recreation facilities, buildings, streets, and the designation of commemorative street names and plaques that are compatible with community interest and will enhance the values and heritage of the City of Amarillo.

Historic Names means a name that commemorates:

- a. a person who significantly contributed to the cultural, economic, social, religious, or political heritage of the city;
- b. a site or area where there occurred historic events which significantly contributed to the cultural, economic, social, religious, or political heritage of the city; or
- c. a person or family founding or traditionally associated with the area where the street is located.

Sec. 4-6-154. – Application.

An application for a land or facilities name change must be filed with the city secretary on an application form furnished by that department. The application must include the following:

- 1. The application fee. The City Council may waive the application fee if the City Council finds that payment of the fee would result in substantial financial hardship to the applicant.
- 2. Fees associated with administration and hard costs for the sign or plaque placement will be at the expense of the applicant, such as sign procurement and installation costs. The payment of the application fee is required at time of application submission.
- 3. A statement of the reasons supporting a name change. The applicant shall be able to provide clear evidence that the individual to be honored has made a significant contribution to the economic vitality and/or quality of life in the Amarillo community.
- 4. Commemorative plaques are an alternative to naming/renaming a facility. These plaques can be used to name a common area, such as a conference room in a city facility, or a gathering place within a city park.
- 5. The existing and proposed name(s).

Sec. 4-6-155. - Standards.

1. In general.

- a. The applicant shall be able to provide clear evidence that the individual to be honored has made a significant contribution to the economic vitality and/or quality of life in the Amarillo community.
- b. Naming shall begin early in the development and/or acquisition as possible.
 - i. Municipal facilities may be given the same name as a school site, where the sites abut one another
 - ii. <u>Subdivision names may be given where park lands are adjacent to or lie</u> within the subdivision
 - iii. Municipal recreation centers that are a part of or lie within the boundaries of a park shall bear the name of that park unless the park name cannot be incorporated in the facility name, or there is a compelling reason for the center to be named under the guidelines and criteria in paragraph 2 of this section.
- c. Names should be appropriate to the park, City-owned building, or recreational facility by reflecting the native wildlife, history, flora, fauna, geographic area, or natural geologic features related to the City of Amarillo.
- d. Names can be from significant historical events, cultural attributes, a local landmark or for a historical figure.

- e. Areas that can be recognized include: Points of entry, walkways, trails, room or patio within a City-owned building, recreational facilities such as group picnic areas, and physical features.
- f. Names which reflect the City's ethnic and cultural diversity are encouraged.

 Signage shall be in English.
- g. The renaming of land or facilities may be considered if exceptional circumstances exist, but should not be a common practice. In such circumstances, care must be taken to avoid renaming because the purpose of the prior naming had become obscured over time (and thus eliminate appropriate recognition or honor).
- h. This ordinance shall not supersede the city's right to seek and receive revenue by contracting the naming rights related to any facilities where such option is appropriate.

2. Guidelines and criteria.

- (a). Names honoring deceased individuals, groups, or families should be based on one or more of the following criteria:
 - i. Made lasting and significant contributions to the protection of natural or cultural resources of the City of Amarillo;
 - ii. Made substantial contributions to the betterment of the City of Amarillo which has positively impacted the lives of citizens of the City of Amarillo,
 - iii. Be associated to an economic development or redevelopment activity in fulfillment of the City's mission;
 - iv. Commemorates a significant historical event;
 - v. Contributed outstanding civic service to the City for a minimum period of ten (10) years.
 - vi. Prohibited until at least two years after the death of the person to be honored or the occurrence of the event to be commemorated.
 - (b). Names of living persons shall be considered only under one or more of the following circumstances:
 - vii. The honoree contributed 50% or more of the cost of a major facility. A contribution is not required to be monetary (example: land or building)
 - viii. The honoree initiated or contributed major time to the establishment of the City project;
 - ix. The overwhelming belief (public opinion) that the honoree would be likely be honored for that facility posthumously;
 - x. No other individual now living has, or is likely to have, greater public support for being honored;
 - xi. The honoree has given extraordinary service to the City and to the community;

- xii. The honoree has attained national or international prominence and achievement.
- (c). Naming after an individual who has served as a City official or as a City employee shall occur after the person has separated from City service and should be based on one or more of the following criteria:
 - xiii. Made contribution over and above the normal duties required by their positions.
 - xiv. Had a positive impact on the past and future development of programs, projects, or facilities in the City of Amarillo.
 - xv. Made significant volunteer contributions to the community outside the scope of their job.
 - xvi. Had exceptionally long tenure with the City of Amarillo; a minimum of ten (10) years.
- xvii. Significant public support for a memorial to the City official or City employee on the occasion of their death or retirement.
- (d). Waiver. The City Council, by a three-fourths vote of its members, may waive any of the standards contained in this section when waiver would be in the public interest and would not impair the public health, safety, or welfare.
