

NOTICE OF PUBLIC MEETING

AMARILLO METROPOLITAN PLANNING ORGANIZATION

The Amarillo Metropolitan Planning Organization (MPO) will hold a public meeting for development of the:

2015-2040 Metropolitan Transportation Plan (MTP)
and
2015-2018 Transportation Improvement Program (TIP)

The 2015-2040 MTP is a 25-year plan to identify the development of future transportation improvements for the Amarillo Metropolitan Area. Amarillo's 2015-2018 TIP is being developed to implement transportation projects identified in the MTP. The TIP contains four years of federally funded and regionally significant non-federally funded projects with cost estimates and funding sources. The TIP and the MTP are both financially constrained planning documents. Transportation projects done within the Amarillo MPO's boundary must be in the TIP to be eligible for federal funding. The draft MTP will be the subject of public meetings until consideration for adoption by the MPO Policy Advisory Committee in October 2014. The draft TIP will be the subject of public meetings until consideration for adoption by the MPO Policy Advisory Committee in April 2014. Interested citizens are invited to join in the preparation and development of these documents, which address the Amarillo Metropolitan Area's transportation needs.
