2. **ORDINANCE NO. 7475**:

This is the first reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Greenways Public Improvement District (PID). This ordinance is recommended for approval by a unanimous vote of the Greenways Public Improvement District Board of Directors.

3. **ORDINANCE NO. 7476:**

This is the first reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Quail Creek Public Improvement District (PID). This ordinance is recommended for approval by a unanimous vote of the Quail Creek Public Improvement District Board of Directors.

4. **ORDINANCE NO. 7477:**

This is the first reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Vineyards Public Improvement District (PID). This ordinance is recommended for approval by a unanimous vote of the Vineyards Public Improvement District Board of Directors.

5. **ORDINANCE NO. 7478**:

This is the first reading of an ordinance changing the zoning of Lots 4 and 5, Block 2, Ridgeview Medical Center Unit No. 2, in Section 43, Block 9, BS&F Survey, Potter County, from Planned Development 145 to Office District 1 in the vicinity of Coulter Street and Fleming Avenue for medical office and pharmacy uses. This is recommended for approval by a 6:0 vote of the Planning and Zoning Commission.

6. **ORDINANCE NO. 7479**:

This is the first reading of an ordinance vacating a portion of an existing 20 foot alley in Block 6, Skyline Terrace Unit No. 2, in Section 135, Block 2, AB&M Survey, Potter County, in the vicinity of Northeast 24th Avenue and Manhattan Street. This vacation request is develop the site with the Travis 6th Grade Academy. This is recommended for approval by a 6:0 vote of the Planning and Zoning Commission.

7. **ORDINANCE NO. 7471**:

This is the second and final reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Colonies Public Improvement District (PID). The Colonies PID is located within the Colonies Subdivision in S.W. Amarillo.

8. **ORDINANCE NO. 7472**:

This is the second and final reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Point West Public Improvement District (PID). The Point West PID is located adjacent to the Amarillo Medical Center in West Amarillo.

9. **ORDINANCE NO. 7473:**

This is the second and final reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Tutbury Public Improvement District (PID). The Tutbury PID is located within the Tutbury Subdivision in S.W. Amarillo.

10. **ORDINANCE NO. 7474**:

This is the second and final reading of an ordinance adopting the 2014/2015 budget and five (5) year service plan, along with establishing and levying an annual property assessment for the Redstone (PID). The Redstone PID is located South of Coulter Street and Hollywood Road in Amarillo.

11. RESOLUTION – TEXAS RAILROAD COMMISSION PROPOSED RULES:

This resolution expresses the City of Amarillo's opposition to certain pending rule amendments before the Texas Railroad Commission regarding natural gas rate case proceedings which could have a detrimental impact to rate payers in the City.

13. **CONSENT AGENDA**:

It is recommended that the following items be approved and that the City Manager be authorized to execute all documents necessary for each transaction:

A. Award - Elevator Repairs at Amarillo Civic Center:

American Elevator Company, Inc. -- \$68,268.00

This item awards a contract for repairs to the north elevator at the Amarillo Civic Center that was damaged during the flooding. The elevator is the only ADA accessible elevator to the auditorium. This contract is part of the insurance claim and has been reviewed and approved by FM Global Insurance.

B. Award – Water Diversion Improvement:

Low responsive bidder: MH Civil Constructors, Inc. -- \$85,899.88

The item awards a contract for the construction of a bulkhead to divert drainage water and prevent damage to site improvements at Fire Station #12 at 3198 Southwest 58th Avenue. Funding for the project is available from the approved 2013-2014 Capital Improvements Project.

C. <u>Award – Flexible Aggregate Base Material Annual Contract</u>:

Award to low responsive bidder: Texas Sand & Gravel, Inc. -- \$193,500.00

This item approves the annual supply contract for flexible aggregate base material. This material is used by the City Street Department in the maintenance and repair of unpaved streets and alleys. The contract will provide 15,000 tons of material to be purchased and delivered as-needed throughout the year. Funding for this purchase is available in the approved Street Department repair and maintenance budget.

D. Acceptance – Consolidated Public Health Grant Awards:

Texas Department of State Health Services -- \$1,400,579.00

This item accepts the funding awards for seven grant programs for fiscal year 2014-2015 from the Texas Department of State Health Services (DSHS) for the Amarillo Department of Public Health. The consolidated contracts represent an overall 2% decrease in funding from the current fiscal year. The following programs will be funded effective September 2014:

This item approves a change order to the construction contract with MH Civil Constructors for the relocation of water and sewer mains within the Texas Department of Transportation Right of Way along Loop 335 from Interstate-27. The change order provides for use of alternative work to the originally planned pipebursting of the existing sanitary sewer mains due to conditions discovered during the process. TXDOT is expected to participate in this change order and reimburse 65% of the cost to the City.

F. Approval - Printing Services Contract:

Award to best-evaluated proposer: Zip Print -- \$85,813.25

This item awards a contract for offset and digital printing services to the City of Amarillo. This contract will provide digital and offset printing services to multiple City Departments. The heaviest user departments include Accounting, Civic Center, Parks and Recreation, and the City Print Shop. The proposed contract is for one-year with four (4) one-year options to renew. Funding for the contract is available from the approved Departmental Operating Budgets.

G. Dedications and Acceptances:

- 1) Dedication of a 0.41 acre drainage easement in Section 138, Block 2, AB&M Survey, Potter County, for Bowie 6th grade campus.
- 2) Dedication of a 20' sanitary sewer easement and a 50' temporary construction easement in Section 48, Block 9, BS&F Survey, Potter County.
- Dedication for a 5 foot pedestrian access easement in Section 153, Block
 AB&M Survey, Randall County to install a sidewalk for through-access to Southeast 46th Avenue.
