The invocation was given by Bob Schroeder, Hillside Christian Church. Mayor Harpole led the audience in the Pledge of Allegiance.

<u>ITEM 11</u>: Mayor Harpole presented a resolution expressing the City of Amarillo's opposition to certain pending rule amendments before the Texas Railroad Commission regarding natural gas rate case proceedings which could have a detrimental impact to rate payers in the City.

Mr. Atkinson stated the Texas Railroad Commission does not regulate railroads, they regulate both the production of oil and gas throughout the State of Texas. They are also the final detriment for rate cases or rate setting that is employed by natural gas utilities. Mr. Atkinson further explained the procedures when the natural gas utility desired a rate increase. Mr. Atkinson stated that the proposed rule amendments would require all cities to presume that they all act in the same common interest. Cities could not represent themselves, they would limit discover and rate case costs to be recovered. Mr. Atkinson suggested the Railroad Commission not adopt the proposed rules and that the Commission not propose or consider any further rules that would restrict a City and its locally elected officials from meaningful participation in natural gas rate cases. Mayor Harpole responded by stating the pending rules would take away local representation and local control. Motion was made by Councilmember Eades, seconded by Councilmember Green, and that the following captioned resolution be passed:

ITEM 12: Mayor Harpole advised that appointments are needed for the Parks and Recreation Commission. Motion was made by Councilmember Green seconded by Councilmember Simms and unanimously carried for appointment of Daniel Bradley and George DeCoux and the reappointed of Renee McCown, such terms to expire on 07/01/2017. Voting AYE were Mayor Harpole, Coucilmembers Green, Eades, Escajeda and Simms; voting NO were none; the motion carried by a 5:0 vote of the Council.

ITEM 13: Mayor Harpole presented the consent agenda and asked if any item should be removed for discussion or separate consideration. There were none. Motion was made by Councilmember Simms, seconded by Councilmember Escajeda, and unanimously carried, to approve the consent agenda and authorize the City Manager to execute all documents necessary for each transaction.

## A. <u>Award – Elevator Repairs at Amarillo Civic Center</u>: American Elevator Company, Inc. -- \$68,268.00

This item awards a contract for repairs to the north elevator at the Amarillo Civic Center that was damaged during the flooding. The elevator is the only ADA accessible elevator to the auditorium. This contract is part of the insurance claim and has been reviewed and approved by FM Global Insurance.

## B. <u>Award – Water Diversion Improvement</u>: Low responsive bidder: MH Civil Constructors, Inc. -- \$85,899.88

The item awards a contract for the construction of a bulkhead to divert drainage water and prevent damage to site improvements at Fire Station #12 at 3198 Southwest 58<sup>th</sup> Avenue. Funding for the project is available from the approved 2013-2014 Capital Improvements Project.

This item approves the annual supply contract for flexible aggregate base material. This material is used by the City Street Department in the maintenance and repair of unpaved streets and alleys. The contract will provide 15,000 tons of material to be purchased and delivered as-needed throughout the year. Funding for this purchase is available in the approved Street Department repair and maintenance budget.

## D. <u>Acceptance – Consolidated Public Health Grant Awards</u>: Texas Department of State Health Services -- \$1,400,579.00

This item accepts the funding awards for seven grant programs for fiscal year 2014-2015 from the Texas Department of State Health Services (DSHS) for the Amarillo Department of Public Health. The consolidated contracts represent an overall 2% decrease in funding from the current fiscal year. The following programs will be funded effective September 2014:

# E. <u>Approval – Change Order #2 for Water and Sewer Relocations for TXDOT Loop 335 Expansion Project – Phase II:</u>

Original Commitment: \$1,557,651.46
Prior Increase Order: 49,793.81
Amendment #2: 75,825.00
Revised Contract Total: \$1,683,270.27
Net Increase: 8.1%

This item approves a change order to the construction contract with MH Civil Constructors for the relocation of water and sewer mains within the Texas Department of Transportation Right of Way along Loop 335 from Interstate-27. The change order provides for use of alternative work to the originally planned pipebursting of the existing sanitary sewer mains due to conditions discovered during the process. TXDOT is expected to participate in this change order and reimburse 65% of the cost to the City.

## F. <u>Approval – Printing Services Contract</u>:

Award to best-evaluated proposer: Zip Print -- \$85,813.25

This item awards a contract for offset and digital printing services to the City of Amarillo. This contract will provide digital and offset printing services to multiple City Departments. The heaviest user departments include Accounting, Civic Center, Parks and Recreation, and the City Print Shop. The proposed contract is for one-year with four (4) one-year options to renew. Funding for the contract is available from the approved Departmental Operating Budgets.

## G. <u>Dedications and Acceptances:</u>

- 1) Dedication of a 0.41 acre drainage easement in Section 138, Block 2,AB&M Survey, Potter County, for Bowie 6<sup>th</sup> grade campus.
- 2) Dedication of a 20' sanitary sewer easement and a 50' temporary construction easement in Section 48, Block 9, BS&F Survey, Potter County.
- Dedication for a 5 foot pedestrian access easement in Section 153, Block 2, AB&M Survey, Randall County to install a sidewalk for through-access to Southeast 46<sup>th</sup> Avenue.

Mayor Harpole announced that this is the end of the regular agenda, but time is reserved to hear any citizen concerning matters pertaining to City policies, programs or services not on today's agenda. The public forum is set under the Open Meetings Act and that during the public forum the City Council can respond with a statement of fact, a statement of city policy or decide whether to place an item on a future agenda.

Dr. Tim Revell, 4827 Tulip Avenue, stated there are problems with an abandon house in the 4700 block of Tulip Avenue. Joan Cresap, 414 Cedar Meadow Circle, inquired as to who was responsible for drainage problems in the Plum Creek area. She also inquired about the Willow trees in the drainage area which have now begun to spring up in her yard. There were no further comments.
