2. **CONSENT AGENDA:**

It is recommended that the following items be approved and that the City Manager be authorized to execute all documents necessary for each transaction:

A. Purchase – Wastewater Sludge Removal Trailer:

Award to G&H Manufacturing on Houston-Galveston Area Council Cooperative Purchasing Contract: \$57,544.00

This item is the purchase of a specialized trailer to transport wastewater sludge from the City Wastewater Treatment Plants to the City Landfill. The requested unit is a hydraulic trailer that lifts, loads and empties the 32 foot roll-off containers used in this activity. This purchase represents a replacement for a 2001 model trailer that has surpassed its useful service life. Finding for this purchase is in the approved FY 2009/2010 Wastewater Treatment Capital Improvement Program budget.

B. <u>Acceptance – Shelter Plus Care Program Grant:</u>

This is acceptance of a 2010/2011 grant from the U.S. Department of Housing and Urban Development (HUD) in the amount of \$343,884 for continuation of the City's Shelter Plus Care Program. This program provides rental subsidies for a total of 50 housing units to assist homeless, disabled individuals with a chronic mental illness and their families. Texas Panhandle Mental Health Mental Retardation provides the match for this program and administers this grant through an agreement with the City. This grant has increased by \$54,672 over the 2009/2010 grant award of \$289,212.
