This resolution sets the date and time for a public hearing on October 4, 2018, at 4:00 p.m. to determine if the properties at 610 NW 12th Avenue, 516 E Hastings Avenue and 2114 Tank Lane constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
