2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on November 1, 2018, at 4:00 p.m. to determine if the properties at 2112 SW 2nd Avenue, 1423 NW 12th Avenue, 302 S Austin Street and 905 N Jefferson Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on November 15, 2018, at 4:00 p.m. to determine if the property at 907 E Amarillo Boulevard constitute public nuisance and thereby declare as a dangerous structure and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
