- ITEM 1: Chairwoman Street established that a quorum was present and called the meeting to order.
- ITEM 2: Chairwoman Street requested a motion to approve the minutes of the October 1, 2018 Board of Directors meeting. Director Bruckner made a motion to approve as presented. Vice-Chairman Brown seconded the motion. The motion was approved.
- ITEM 3: Chairwoman Street adjourned the meeting into executive session at 11:06 am.

No action was taken during the executive session because none is permitted by law. The public session reconvened at 12:29 pm.

ITEM 4: President Albrecht provided an overview of the latest financial statement. We are starting out the fiscal year with a retail sales tax revenue increase of 4.2%, compared to last year.

Director Gualtiere asked if there is a list of the gifts received by Texas Tech for the Veterinary School donations that would reduce the Amarillo EDC's commitment, which he had previously requested. Sr. Vice-President Nelson said that our commitment is currently at \$55m. There was additional discussion regarding the project, no action was taken.

President Albrecht added that the Texas Tech Veterinary School is a large component of the proposal to the USDA.

President Albrecht announced the separation from employment of Sr. Vice-President of Business Development Brian Jennings. His final day is at the end of the month.

He stated that the job description for a Vice-President is being finalized as well as what

publications and websites the position opening will be posted.

After the Vice-President position has been filled, the organization will begin a search for a Business Development staff member.

President Albrecht updated the board on additional accountability documents that have been developed for travel expenses. He also provided a recap on recent conferences and tradeshows attended.

President Albrecht introduced the Amarillo EDC's new Social Media Policies. Vice-President of Strategic Marketing & Communications Hales stated that the policies have been developed by the Digital Marketing intern.

President Albrecht stated that on January 31, 2019 a State of the Economy will be held, sponsored by the Amarillo EDC. An economist as well as guest speakers will address national and local demographic information.

Vice-President Hales stated that Scott Nations, a CNBC regular contributor and a commodities trader with the Chicago Board of Exchange will be the keynote speaker. Tony DeLisi, who provided the Amarillo EDC's strategic review two years ago is also scheduled to be a speaker. VP Hales stated she is seeking someone from the Kaufman Foundation to speak to small business entrepreneurship.

- ITEM 6: Chairwoman Street asked for any comments or questions from the public in attendance. There was none.
