- (1) Speed control in the Mrs. MD Oliver-Eakle of Plemons Subdivision.

 David Szmagalski, Traffic Operations Technician, stated that the Traffic Engineering

 Department is nearing completion on parking studies and turning counts in the Mrs. MD

 Oliver-Eakle of Plemons Subdivision, which will be submitted to Kimley-Horn and Associates, the engineering consultant.
- (2) Overview of connectivity of city bicycle lanes on 3rd Ave. from Adams St. to Grant St. Kyle Schniederjan, Director of Capital Project and Development Engineering, reported that the contract for the overlay project on S. Bell St. had been cancelled, and he said the contract will be rebid in the near future. He said the decision was made to cancel the overlay project for 3rd Ave. for this striping season. He stated a paving assessment would be done on all city roads next year, and he stated 3rd Ave. should remain on the priority list for Fiscal Year 2018-19.
- (3) City of Amarillo Community Investment Program explanation and opportunities to seek funding from the Program.
 - Mr. Schniederjan gave an overview of the City of Amarillo Community Investment Program (CIP). He passed out handouts of the Community Investment Program Fiscal Year 2017/18 Fiscal Year 2021/22 and the City of Amarillo Annual Budget for Fiscal Year 2017-2018. He

said the City began several years ago allocating capital improvement funding in five year periods, separating the funds for capital improvements from the city budget. He said his purpose was to enable the committee to take advantage of all available funding opportunities, whether through the General Fund, the Community Investment Program (CIP), or other means, such as a public-private partnership. He stated the funding opportunities are typically divided into three categories: 1. Policies; 2. Programs; and 3. Projects. He reported that Policies have a lasting impact and are considered a direction to city staff, Programs have people assigned to it, and Projects consist of a physical construction. He recommended the committee focus on policies since they would have a more lasting impact.
