This resolution sets the date and time for a public hearing on February 7, 2019, at 4:00 p.m. to determine if the properties at 4414 E Amarillo Boulevard, 4620 E Amarillo Boulevard, 711 S Kentucky Street and 1021 N Washington Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
