# B. CONSIDER AWARD - BID NO. 6225/PROJECT NO. 530003 - FY 2017-2021 COMMUNITY INVESTMENT PROGRAM: LARGE VALVE REPLACEMENT - PHASE 1:

Amarillo Utility Contractors, Inc. -- \$443,220.00

This item is to consider award of the construction contract for the furnishing and installation/replacement of five (5) large diameter gate valves in the water distribution system with corresponding appurtenances to improve operations and maintenance.

- 1. Two valves located on Amarillo Boulevard and Marrs Street;
- 2. Two valves located on the existing line in Travis Street at Wolflin Avenue and 26<sup>th</sup> Avenue; and
- 3. One valve at Crockett Street and I-40 West.

Voting AYE were Mayor Nelson, Councilmembers Powell, Sauer and Smith; voting NO were none; the motion carried by a 4:0 vote of the Council.

#### **NON-CONSENT ITEMS**

ITEM 3A: Mayor Nelson presented an item for approval for a Tax Increment Reinvestment Zone (TIRZ) #1 Developer Agreement for the DHY Enterprises commercial building located at 300 Southwest 10<sup>th</sup> Avenue. A \$35,000 reimbursable grant at project completion and a 70% tax rebate over a 10-year period, to assist with the fiscal impacts created with the renovation and restoration of this property due to its age and condition. This item was presented by Andrew Freeman, Director of Planning and Development Services. Motion was made by Councilmember Powell, seconded by Councilmember Sauer, that this item be approved as presented.

Voting AYE were Mayor Nelson, Councilmembers Powell, Sauer and Smith; voting NO were none; the motion carried by a 4:0 vote of the Council.

ITEM 3B: Mayor Nelson presented an item for review, consideration and possible approval for the stop-loss policy for the City's employee medical and pharmacy plan. This policy provides stop-loss protection to the medical and pharmacy plan for any individual claim that exceeds \$750,000. This item was presented by Mitch Norman, Director of Human Resources. Motion was made by Councilmember Sauer, seconded by Councilmember Smith, that this item be approved as presented.

Voting AYE were Mayor Nelson, Councilmenthers Powell, Sauer and Smith, voting NO were none; the motion carried by a 4:0 vote of the Council.

ITEM 3C: Mayor Nelson presented an item for discussion, consideration and possible approval for a location incentives agreement with Asset Protection Unit, Inc. for the creation of new jobs in Amarillo. The expansion incentives are performance based for the creation of up to 125 new jobs over a five year period. The agreement prescribes a total grant of up to \$1.25 million dependent upon specific performance achievements detailed in the agreement. The agreement requires Asset Protection Unit, Inc. to create the jobs and payroll first and then receive incentive payments upon the achievement of annual performance metrics. This item was presented by Doug Nelson, Amarillo Economic Development Corporation. Jim Del Vecchio, Asset production Unit, Inc. spoke about their business. Motion was made by Councilmember Powell, seconded by Councilmember Sauer, that this item be approved as presented.

Consider approval of a resolution authorizing the Amarillo Convention and Visitor Council to bid on hosting the 2023 Texas Recreation and Park Society Institute and Expo.

#### **Agenda Item Summary**

The Amarillo Convention and Visitor Council is submitting a bid to host the 2023 TRAPS Institute and Expo. The bid application requires a resolution pledging the resources necessary to support the Institute from the governing entity; involvement by the community's parks and recreation agency is required as part of the bid.

#### **Requested Action**

Request City Council approval of the resolution.

On September 4th, 2018, Council approved a resolution authorizing the Amarillo Convention and Visitor Council (CVC) to bid on hosting the 2021 Texas Recreation and Park Society (TRAPS) Institute and Expo. The Amarillo CVC submitted a bid for the 2021 and was not selected as the host community for the 2021 TRAP institute and expo. In follow up conversations with the Amarillo CVC, TRAPS requested that Amarillo submit an additional bid to host the 2023 TRAPS institute and expo.

TRAPS is a nonprofit educational and professional organization founded 81 years ago to advance the profession of parks, recreation, and leisure services in Texas.

Historically the TRAPS Annual Institute averages between 1,000-1,500 attendees, including approximately 700-1,200 delegates, speakers, and/or volunteers; and an average of 250 exhibitors, who meet annually to interact, network, and learn about trends, new products and services during the annual Texas Recreation and Park Society Institute.

The average economic impact upon a host community is approximately \$500,000.

#### Agenda Item Summary

This item is to replace Scott Bentley as Chair of TIRZ #1 Board. He was recently reappointed as Chair on August 28, 2018. Mr. Bentley was appointed to the Amarillo Economic Development Corporation Board on November 27, 2018 and will no longer serve on TIRZ #1.

According to Ordinance 7012 establishing the TIRZ, the City Council shall annually designate a member of the Board to serve as chairperson of the Board, and the Board shall elect from its members a vice chairperson or other officers as it considers appropriate.
