# IV. Regular Agenda:

1: <u>Discussion of Subdivision Ordinance Amendment, Section 4-6-59 (d) (1) (2) regarding partial release requirements.</u>

Kelly Shaw, Development Customer Service Coordinator, stood to present the proposed amendments to the current Subdivision Ordinance regulations regarding "partial release" of cash surety. Mr. Shaw went over the procedure of public improvement and submitting surety. Mr. Shaw explained the process that has led to the most recent updates for the wording of the amendment, noting the various concerns that all parties had in trying to end with sufficient language. Mr. Shaw noted that if approved, it would allow those who submit a cash surety to request reimbursements,

tied to partial completion of improvements, in a shorter timeframe than is currently allowed. City Staff then took questions from the Commission.

The Commission agreed that the amendment would be voted on during a future meeting.

- 2: SUDIVISION PLAT/S: The Planning & Zoning Commission has final authority for approval; appeals may be directed to City Council.
- A. P-18-119 Westview Addition Unit No. 5, a suburban subdivision to the City of Amarillo, being a replat of South 26 feet of Lot 7, and all of Lots 8,9 and 10, Block 7, Westview Addition Unit No 2, Situated in Section 226, Block 2, AB&M Survey, Potter County, Texas.

Cris Valverde, Assistant Director, presented this item with consideration of a request for approval of a residential replat which requires a public hearing under Texas Local Government Code 212.015 C. Mr. Valverde ended the presentation with staff recommendation of approval. Mr. Valverde then took questions from the Commission.

Acting Chairman Jones asked if there was anyone in favor or against this item. No comments were made.

Acting Chairman Jones made a note that Commissioner Ford would be abstaining from voting.
