Votes or final decisions are made only in open Regular or Special meetings, not in a work session or executive session.*

2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on April 4, 2019, at 4:00 p.m. to determine if the properties at 4209 SE 15th Avenue, 2009 NW 19th Avenue and 1711 N Washington Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 4414 E Amarillo Boulevard.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 711 S Kentucky Street.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1021 N Washington Street.
