3. DISCUSS AND CONSIDER CITIZEN SURVEY.
This item is to discuss and consider the creation of a citizen survey to gauge public interest in projects or programs aimed to enhance environmental improvement efforts in Amarillo.
4. RECEIVE UPDATE ON TIRE ORDINANCE.
This item is to receive an update from Building Safety staff regarding the effect of Ord. No. 7631 (codified at Title VIII, Chapter 8-3, Article V, of the Amarillo Municipal Code) on the illegal dumping of tires in the city.
5. DISCUSS POTENTIAL PROJECTS TO CO-SPONSOR WITH THE BEAUTIFICATION AND PUBLIC ARTS ADVISORY BOARD.
This item is to discuss areas that the Environmental Task Force can work with the Beautification and Public Arts Advisory Board to meet mutual goals regarding beautifying the city. A representative of the Beautification and Public Arts Advisory Board may be present.
6. PUBLIC COMMENT.

Citizens who desire to address the Environmental Task Force with regard to matters on the agenda or having to do with the City's policies, programs, or services will be received at this time. The total time allotted for comments is 30 minutes with each speaker limited to three minutes. The Environmental Task Force may not discuss items not on this agenda, but may respond with factual, established policy information, or refer to staff.
