2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on July 18, 2019, at 4:00 p.m. to determine if the properties at 1940 NW 18th Avenue, 3105 N Cleveland Street and 506 N Washington Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 1205 N Fillmore Street.

Interested citizens may comment on matters pertaining to policies, programs or action of the Condemnation Appeals Commission.
