Chairman Parker opened the meeting, established a quorum and conducted the consideration of the following items in the order presented. Cris Valverde gave the recommendations for the agenda items.

- 1: SUBDIVISION PLAT/S: The Planning and Zoning Commission will consider the following subdivision plat/s:
- A. P-19-14 A. R. Glenn Unit No. 3, a Suburban Subdivision to the City of Amarillo, being a replat of a portion of Tract 20, A. R. Glenn Unit No. 1, in Section 134, Block 2, AB&M Survey, Potter County, Texas.

VICINITY: Amarillo Street and Canadian Avenue DEVELOPER/S: Jamie and Maria Alvarez

Cris Valverde, Assistant Director, presented the above-proposed replat. Mr. Valverde ended the presentation with a staff recommendation of approval, advising that approval would be contingent

on the description matching the official drawing regarding mete and bounds. Mr. Valverde then took questions from the Board.

A neighbor stood with concern regarding the property shift on the drawing possibly encroaching on his property. City staff and the Board noted that the description change would not disrupt his property.
