2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on October 3, 2019, at 4:00 p.m. to determine if the properties at 1419 NW 10th Avenue and 3501 S Taylor Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 723 N Garfield Street.
  
4. **Resolution – Public Hearing**  
This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 902 N Lincoln Street.
