**Variance Requested:** Reduce the required number of off street parking spaces from 70 to 44.

Karl Taylor-Restine with AERC (Amarillo Emmanuel Revival Church) handed out a short summary stating they would like to build a fellowship hall which would expand the parking area by 33%. This is still less than is required. The fellowship hall would not be used simultaneously with the sanctuary which would not increase the need for additional parking. There were no comments in opposition. Mr. Rhynehart asked for city recommendations. Ismael "Izzy" Rivera Jr. approached and stated that Cris Valverde with the Planning department is not available to answer the question, but as stated in the staff summary the City does approve the variance. Claudia Stuart asked is this organization non-profit. Mr. Taylor-Restine did confirm that it is non-profit. Cory Mathis wanted clarification with the difference between one (1) for every four (4) to one (1) for every three (3). Mr. Taylor-Restine stated that it is one (1) for every three (3). Motion was made by Ms. Claudia Stuart to approve said variance. Mr. Paul French seconded the motion. The board approved the variance 4:0.
