Dr. Rebecca Scott made motion for Dr. Medford, Dr. Bradford, Dr. Urban, and Dr. Meikle to be confirmed as Deputy Health Authorities. Second by Kevin Hawkins. All in favor.

# **Item 5: Discuss and Consider: Updated Cooperative Agreement**

Casie Stoughton, Director of Public Health, presented the updated Cooperative Agreement. (Attached)

- Cooperative Agreement last updated in 1997
- The members of the Bi-City-County Public Health District wish to replace the original contract with the terms of this Cooperative Agreement and continue the operation of the District under the new name, Amarillo Area Public Health District, on October 1, 2019.

### **Changes/Updates:**

# **Article II. Definitions**

Add a definition for "Departments"

2.5 <u>Department:</u> Departments providing services to the District, Public Health, Environmental Health, WIC, and Animal Management and Welfare. Each department has a separate mission and service coverage area as defined by funding and is a department in the organizational structure of the City of Amarillo.

Belinda Taylor made a motion to accept the changes in 2.5 Department. Second by Dr. Rebecca Scott. All in favor.

## **Article IV. Health Board**

**4.8** <u>Residency.</u> To be eligible for appointment, a Representative must currently reside in and have resided in their respective jurisdiction for at least two (2) years before the date of the Representative's appointment. A member shall be removed from the Board if they no longer meet the residency requirements.

Dr. Rebecca Scott made motion to accept the changes in 4.8. Second by Kevin Hawkins. All in favor.

## **Article VII. TERM OF THIS AGREEMENT**

7.3 <u>Amendments</u>. This Agreement may be modified or amended during its term upon written agreement with a majority approval from the board, and then, the majority approval from governing bodies.

Judi Smith made a motion to accept the changes for 7.3 Amendments. Second by Belinda Taylor. All in favor.

Kevin made a motion to approve the Cooperative Agreement as amended. Second by Belinda Taylor. All in favor.

# **Item 6: Discussion: Topical Update from Health Authority**

Dr. Milton, Health Authority of Public Health presented a topical update to the board.

- Legionnaires' disease in the community
  - o Commonly a type of pneumonia
  - o Legionella likes warm water
  - Most people contract the disease when they are near a water source
  - o First recognized in 1976
  - o Best way to screen for Legionella is with antigen urine testing.
  - All positive tests are required to be reported to the Public Health department and is followed up with an extensive investigation to find the source.

Casie Stoughton, Director of Public Health, presented the Public Health report.

- Live with new EMR (Patagonia)
- New program:
  - o Community and Clinical Health Bridge Grant
    - Starts November 2019
    - Work with chronic conditions and obesity
  - o Texas Healthy Babies Grant
    - Purchased \$10,000.00 worth of car seats and cribs
    - Health Planner is working on a plan to distribute the car seats and cribs
- Preparing for Back to School Clinics
- Communicable Disease Program
  - o Working with interns from Texas Tech
  - o 3 team members from Public Health have worked on 2,075 investigation cases

## **Animal Management and Welfare**

Dr. Kathryn Wrubel, Director of Animal Management & Welfare and Christina Fischer presented the Animal Management & Welfare report.

- Numbers are lower
  - Staffing shortage for field officers
  - o Run priority calls
  - Working hard to recruit new staff members
  - o Currently have 5 Animal Control Officers
  - Supervisors are running calls
  - o New recruiting methods
  - o Adoptions have decreased, but is typical around this time of year

- o Positive rabies cases have decreased
- Applied for a Pet Retention grant through Pets Marts Charities
  - Micro chipping event at El Alamo Park
  - Every two months the program goes out to Tent City and other homeless concentration camps to offer free services for their pets
    - Next event: August 7, 2019
    - Free spay and neuter vouchers
    - Vaccines
    - Deworming
    - Collars
    - Flea and tick prevention
- New Director for Animal Management & Welfare
  - o Dr. Kathryn Wrubel
- Staffing
  - o Animal Control Officers Authorized for 14 officers and 2 supervisors
  - Currently have 5 officers and 2 supervisors
