Mr. Robinson established a quorum, called the meeting to order at 10:02 a.m., and the following items of business were conducted:

<u>ITEM 1.</u> Consider Minutes. Mr. Robinson presented the minutes from the last regular meeting held August 21, 2019. Mr. Mason made a motion to approve the minutes as presented. Ms. Bonner seconded the motion and it carried unanimously.

<u>ITEM 2.</u> Consider Investment Resolution. Ms. Moralez presented the Fund's Investment Resolution at August 31, 2019. A motion was made by Mr. Wray, seconded by Mr. Peterson and unanimously carried to approve the investment resolution as presented.

ITEM 3. Presentation of Revenue and Expenditures Summary. Ms. Moralez presented the Fund's Summary of Revenue and Expenditures at August 31, 2019 and reviewed a total market value of \$181,789,919.00. She reviewed total receipts of \$639,928.47 versus total disbursements of \$1,197,903.76. Ms. Moralez explained that the Fund's investments were within the Policy limits with 5.35% invested in cash, 20.61% in bonds and 74.04% in stock. Ms. Moralez noted that all employee/employer contributions were made on time and at the correct percentages for the month of August.

<u>ITEM 4.</u> Presentation of the Mayor's Board Appointee. Joseph Peterson was appointed by the Mayor to the Amarillo Firemen's Relief and Retirement Fund Board of Trustees.

ITEM 5. Oath of Office. The Board administered the Oath of Office to Mr. Peterson.

ITEM 6. Presentation of Trading Report. No action was taken on Item 6.
