2. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on February 6, 2020, at 4:00 p.m. to determine if the properties at 3012 NE 13th Avenue, 100 W Central Avenue, 500 S McMasters Street and 1400 N Ong Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

3. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 3611 NE 12th Avenue.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 2204 S Lincoln Street.
