2. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on March 19, 2020, at 4:00 p.m. to determine if the properties at 1213 S Austin Street, 918 N Cleveland Street and 3703 Fountain Terrace constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 3012 NE 13th Avenue.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 500 S McMasters Street.

6. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 1400 N Ong Street.
