IT IS also understood and agreed that the Surety reserves the right to cancel this bond by giving the Principal and the City of Amarillo, Texas thirty (30) days actual written notice prior to the date of cancellation provided however, it is hereby expressly understood and agreed that any such cancellation by the Surety herein shall not relieve said Surety of any liability which shall have arisen hereunder by virtue of any breach or default of the Principal prior to the effective date of such notice of cancellation nor shall such cancellation prejudice the rights or remedies of any Obligees against said Surety, for any liability or cause of action that shall have arisen prior to such effective date of cancellation.

IT IS also expressly understood and agreed that should Obligees, or either of them, be required to resort to litigation for a reasonable and timely enforcement of their, or its, rights, hereunder then Obligees, or either of them, shall be awarded their attorney fees in a reasonable amount.

IT IS also expressly understood and agreed that suspension or revocation of the license of the Principal herein shall not of itself affect or terminate the liability of either the Principal or Surety herein.
