Notice and Record of Meeting of Political Subdivision's Governing Body (If Applicable to Political Subdivision):

1. The requirements to run for an office of the City Council are:
 - a. be a resident of the City of Amarillo for twelve months,
 - b. be a registered voter,
 - c. not be indebted to the City,
 - d. not hold any other public office of emolument or be interested in the profits or emolument of any contracts, job, work or service for the municipality, or
 - e. interested in the sale to the City of any supplies, equipment, material or articles purchased.
2. The Mayor and four Councilmembers are elected at large at the regular municipal election to be held on May 1, 2021.
3. The elective officers of the City shall consist of a Mayor and four Councilmembers. The Councilmembers shall be designated as Mayor, Councilmember No. 1, 2, 3 and 4, each of whom shall be elected to the office for which he is a candidate by a majority of the qualified voters for the City at large. This means that a qualified citizen can file in any of the designated places.
4. A qualified citizen can file an application for a place on the ballot in the office of the City Secretary at City Hall, 601 South Buchanan Street, Third Floor, Room 303. Filing for the office of Mayor and the four Councilmembers begins on Wednesday, January 13, 2021 and ends on Friday, February 12, 2021. The City Secretary's office is open from 8:00 a.m. to 5:00 p.m., Monday through Friday. The application along with other forms and documents can be obtained in the office of the City Secretary.
5. A City Councilmember would need to be available for the City Council meeting each Tuesday. The meetings usually begin about 1:00 p.m. As the City Council begins to review the budget each year, there are usually special meetings held for budget review and discussion. There could also be other special meetings that would be important for City Councilmembers to attend. City Councilmembers are also invited to attend ribbon cuttings, grand openings, banquets and other events and those events are usually something the individual Councilmembers may decide to attend.
6. The City Charter sets out that the Mayor and each Councilmember will be paid \$10.00 for each attended regular meeting of the Council.
