This resolution sets the date and time for a public hearing on September 3, 2020, at 4:00 p.m. to determine if the properties at 1508 SE 9th Avenue, 3113 S Apache Street, 809 N Florida Street and 732 N Roberts Street constitute public nuisances and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.
