THE AMARILLO CITY COUNCIL WILL MEET AND HOLD PUBLIC MEETINGS VIA VIDEO CONFERENCE AND NOTICE IS HEREBY GIVEN IN ACCORDANCE WITH ORDER OF THE OFFICE OF THE GOVERNOR ISSUED MARCH 16, 2020

NOTICE is hereby given that the Amarillo City Council will meet at 1:00 PM on Tuesday, September 8, 2020 by video conference for a regularly scheduled meeting in order to advance the public health goal of limiting face-to-face meetings also called "Social Distancing" to slow the spread of the Coronavirus (COVID-19). The subjects to be considered at the meeting are shown below:

- A. **PURPOSE:** To consider in public hearing on September 8, 2020, at 1:00 P.M., the annual assessment for all property in The Greenways Public Improvement District:

The assessments for The Greenways Public Improvement District are necessary to fund the 2020/21 annual maintenance and administrative costs associated with the common areas, debt service, and account reserve. Individual assessments are \$750 for each Class A lot, \$625 for each Class B lot, \$900 for each Class D lot, and \$1,875 for each commercial acre. The total value of the 2020/21 budget year assessments equal \$671,219.
