2. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**  
This resolution sets the date and time for a public hearing on October 1, 2020, at 4:00 p.m. to determine if the properties at 2404 NW 1<sup>st</sup> Avenue Rear, 1929 NW 15<sup>th</sup> Ave and 4121 S Van Buren Street constitute public nuisances or an accumulation of solid waste and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1508 SE 9<sup>th</sup> Avenue.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 732 N Roberts Street.
