**2. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on November 5, 2020, at 4:00 p.m. to determine if the properties at 2602 Olive Street and 803 Pittsburg Street constitute public nuisances or an accumulation of solid waste and thereby declare as dangerous structures and order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

**3. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 2404 NW 1<sup>st</sup> Avenue Rear.

**4. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located 1929 NW 15<sup>th</sup> Avenue.

**5. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 4121 S Van Buren Street.
