Below is an outline of the requested commitment from each advisory committee member:

### **Online Public Kick-Off**

- Participate in advisory committee meeting #1 orientation; review plan process and role of the advisory committee members; confirm Neighborhood Profile; assign focus group meetings and survey outreach.
- Assist with public interactive activity Survey #1 Resident Kick-Off.
- Volunteer for a COA website video or other promotional materials to encourage participation.
- Identify your focus group for more tailored outreach.

## Visioning and Focus Groups

- February 2021
  - Participate in advisory committee meeting #2 review survey summary, confirm SWOT, and draft vision statement.
  - Co-lead focus group Zoom meetings.
  - Assist with public interactive activity Survey #2 Business Owners.

#### **Goals and Strategies**

#### <u> March – July 2021</u>

- Participate in advisory committee meeting #3 (March) *draft focus areas and goals*.
- Assist with public interactive activity online solutions crowdsourcing for issues identified under each focus area.
- Participate in advisory committee meeting #4 (April) study best practices and inspiration; review public comments from crowdsourcing activity.
- Participate in advisory committee meeting #5 (May) draft strategies and projects.
- Assist with public interactive activity Survey #3 Project Priorities.
- Participate in advisory committee meeting #6 (July) Conduct final project prioritization (based on public survey and City-generated cost estimates).

#### **Projects for Implementation**

Participate in advisory committee meeting #7 – review and confirm projects for implementation.

#### September 2021

• Participate in a joint advisory committee and public Zoom #8 – neighborhood leadership panel Q&A.

#### Final Review

• Participate in advisory committee Meeting #9 (October) – offer final plan comments; begin the transition for those interested from advisory committee to neighborhood association.
