ITEM 3: Introduction of New Interim Director Robert Sherwin:

Rob Sherwin comes with 33 years of law enforcement. He helped Dallas Animal Services for 9 months to help organize field management and shelter operations. Rob is looking to implement a Daily Report Card that will post on the Shelter's website to be visible to the public. He immediately opened up field operations to picking up stray animals. He wants to create transparency with capacity reporting from the Shelter. Rob wants to empower people to make good decisions and support them when decisions are challenged. Rob sees a future with Texas Tech Vet School to work together to train new Vets in Shelter medicine.

Staffing Update: Victoria Medley, worked on getting Trainee's certified. She secured a State Trainer to come and facilitate the training for the 5 Animal Management Officer Trainee's. They completed a 5 day training and are officially AMO I.

New building will be completed by end of November with office furnishings to arrive in December. There will be limited access to AMW during the current COVID 19 protocols. Appointments will be made for adoptions and reclaims. AMW website is getting updated with new ways to connect with the department and to maintain open communication with the public while respecting social distancing.


