**2. Minutes:**

**3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on April 15, 2021, at 4:00 p.m. to determine whether certain conditions of the property at 2306 S Mirror Street constitute a dangerous structure and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

4. **Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 407 S Osage Street.
