**1. Public Comments**

**2. Minutes:**

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on March 18, 2021.

**3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on May 6, 2021, at 4:00 p.m. to determine whether certain conditions of the properties located at 1316 Hillside Street, 5300 Keystone Drive and 4046 Rose Drive constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

4. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on May 20, 2021, at 4:00 p.m. to determine whether certain conditions of the properties located at 1019 SW 15<sup>th</sup> Avenue and 2707 S Williams Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

5. **Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 2306 S Mirror Street.
