1. **Public Comments**

2. **Minutes**

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on April 15, 2021.

3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on June 3, 2021, at 4:00 p.m. to determine whether certain conditions of the properties located at 4211 SE 15th Avenue, 1328 Columbine Street and 2106 Pheasant Lane constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

4. **Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 5300 Keystone Drive.

5. **Update on 1929 NW 15th Avenue**

This item is for the Commission to receive a staff update on the status of the condemnation case for property located at 1929 NW 15th Ave.
