

# **Prioritization Challenge**

The City of Amarillo is updating its Parks & Recreation Master Plan to guide improvements to parks, trails, recreation facilities, and programs over the next 10 years. As a part of the planning process, MIG, Inc., (MIG) conducted a Prioritization Challenge in July of 2021. The purpose of the survey was to collect input on community priorities for investing in Amarillo's park system.

### Methodology

The Parks and Recreation Department conducted an online survey from July 1 to July 25, 2021. A total of 6904 people responded. The survey link was available on the City's website, distributed to City contacts via email, and posted via traditional media and social media to engage the public. The survey link and QR code were also distributed throughout the city on signs posted next to a red tape "X" at various parks. The red x signified the risk that (without more funding) the city may need to close, remove, or transfer maintenance responsibilities for some types of park amenities and facilities.

The survey included 30 questions. It was



available in English. Several questions allowed Figure 1: City poster and X promoting the prioritization challenge.

participants to type or write in their response. For each question, a number "n" is provided for the number of respondents to the individual question. This number is the basis of the percentages shown. The value for n varies for each question since respondents could skip questions when taking the survey. Also, some questions allowed participants to select two or more answer choices, resulting in total counts greater than the number of respondents and total percentages greater than 100%.

While the overall survey results should not be considered statistically valid, the findings are from a broad enough sample that they can help us to identify common themes and concerns when combined with the various community input activities conducted for Amarillo's updated Parks and Recreation Plan. This document summarizes the survey results and key findings. The appendix contains all responses for "other" or write-in options.

## **Respondent Profile**

The questionnaire was distributed across the city to obtain as broad of a response as possible. City staff made additional outreach efforts to elicit responses from geographic areas that are traditionally underrepresented. Respondents identified as Caucasian or white (68%), Hispanic and Latino (11%), African American/Black (2%), Native American (1%), Multi-Racial (2%), and Asian American (1%).
