1. Public Comments

2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on September 16, 2021.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on November 4, 2021, at 4:00 p.m. to determine whether certain conditions of the properties located at 1207 S Buchanan Street, 805 S Florida Street, and 1308 S Lincoln Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures and solid waste accumulations located at 3817 NE 12th Avenue.

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1411 Brook Avenue.

6. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 1101 N Cleveland Street.

7. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 2019 N Cleveland Street.

8. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of solid waste accumulations located at 2017 NW 19th Avenue. The Commission previously heard and tabled this resolution at the regular meeting held on September 2, 2021.
