Votes or final decisions are made only in open Regular or Special meetings, not in a work session or executive session.

REGULAR MEETING

1. Public Comments

2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on January 20, 2022.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on April 7, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 510 SW 2nd Avenue, 2419 NW 10th Avenue, and 817 S Jackson Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1508 SE 5th Avenue.

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 710 Browning Street.

6. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure and an accumulation of solid waste located at 106 S Florida Street.
