3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on March 17, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 1508 SE 5th Avenue, 710 Browning Street, and 106 S Florida Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on April 7, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 510 SW 2nd Avenue, 2419 NW 10th Avenue, and 817 S Jackson Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
