1. Public Comments

2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on February 17, 2022.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on May 5, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 412 NE 10th Avenue, 1203 N Highland Street, 1205 N Highland Street, and 1304 N Tyler Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of an accumulation of solid waste located at 2202 SE 19th Avenue.

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 1629 Hillcrest Street.

6. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 804 N Jefferson Street.
