

# **NOTICE OF PUBLIC MEETING**

## **AMARILLO METROPOLITAN PLANNING ORGANIZATION**

The Amarillo Metropolitan Planning Organization (MPO) will hold a public meeting for development of the:

### **2023-2026 Transportation Improvement Program (TIP)**

Amarillo's 2023-2026 Transportation Improvement Program, or TIP, is being developed to implement transportation projects identified in the Metropolitan Transportation Plan (MTP). The TIP contains four years of federally funded and regionally significant non-federally funded projects with cost estimates and funding sources. The TIP and the MTP are both financially constrained planning documents. Transportation projects done within the Amarillo MPO's boundary must be in the TIP to be eligible for federal funding.

The draft TIP will be the subject of public meetings until consideration for adoption by the MPO Policy Advisory Committee April 21, 2022. Interested citizens are invited to join in the preparation and development of this document, which addresses the Amarillo Metropolitan Area's transportation needs.
